Special Election Town of Buffalo Gap to vote for or against:

Proposition A- Reducing the current one-fourth of one percent sales and use tax for maintenance and repair of municipal streets by one-fourth of one percent and adopting a sales and use tax for general revenue increased by one-fourth of one percent.

Special Election Jim Ned C.I.S.D. to vote for or against:

Proposition A- The issuance of \$25,885,000 school building bonds for the construction, acquisition, rehabilitation, renovation, expansion, improvement and equipment of school buildings in the district, and levying and imposition of taxes sufficient to pay the principal of and interest on the bonds and the costs of any credit agreements. Required statement for all school district bond propositions pursuant to section 45.003, Texas education code: This is a property tax increase.

Proposition B- The issuance of \$7,810,000 school building bonds for the construction, acquisition, rehabilitation, renovation, expansion, improvement and equipment of a new performing arts auditorium, and levying and imposition of taxes sufficient to pay the principal of and interest on the bonds and the costs of any credit agreements. Required statement for all school district bond propositions pursuant to section 45.003, Texas education code: This is a property tax increase.


